### **POSITIONS AVAILABLE**

**PRESIDENT:** Oversees the responsibilities of the chapter; ensures compliance with ICC sub-chapter requirements; attends national WICED annual business meeting; schedules and conducts regular business meetings including the annual business meeting.

**VICE PRESIDENT** (President-elect): Officiates meetings in the Presidents absence; Chairs committees as delegated by the President; coordinates with President and other Officers to develop and maintain the Chapter's long-range goals.

**SECRETARY:** Keeps meeting minutes; maintains meeting records and ensures compliance with meeting requirements; maintains chapter activity records; prepares annual report for national chapter annual business meeting.

**TREASURER:** Maintains chapter financial records including checking account reconciliation and signer designation; settles accounts payable; maintains membership database and changes.

**DIRECTOR AT LARGE (6 positions):** A dynamic, supportive position that provides outreach to assigned areas, member engagement, and training selection. Our goal is to have a director at large assigned to each Region II State that includes Oregon, Washington, Idaho, Alaska, Wyoming, and Montana.
